MEMORANDUM OF UNDERSTANDING

1. PREAMBLE

This Memorandum of Understanding (MOU) is between Survey of India (SoI) and National Disaster Management Authority (NDMA), Ministry of Home Affairs, with the purpose to effectively use WebGIS Services to meet with survey map requirement and survey related Geospatial data application requirements of NDMAin the area of disaster risk management. Provisions of the various technology based solutions have been included in this document for the benefit NDMA to enable them to provide improved Disaster risk information in the country.

Survey of India, a 250 years old organization, is the National Surveying and Mapping Agency under the Department of Science and Technology (DST), Ministry of Science and Technology (MoST), Government of India. Survey of India has played avaluable role in the saga of India's Nation Building. The scientific and development initiatives of the organization have played an indispensable pioneer role in defining the country's priorities for growth and development. Survey of India has mandate to take a leadership role in liberalizing access of spatial data to user groups without compromising with the national security.
