- 2. The adhoc promotion of the Officer Surveyor will be subject to the following conditions:-
 - (i) The adhoc promotion shall be for one year and shall cease on the expiry of one year term, unless other orders are issued in this regard.
 - (ii) The adhoc promotion shall not confer any right to continue in the grade of Superintending Surveyor indefinitely and shall not bestow a claim for regular appointment in the grade.
 - (iii) The service rendered on adhoc basis in the grade of Superintending Surveyor shall not count for the purpose of seniority in that grade and for eligibility for promotion to the grade of Superintending Surveyor. The Officer Surveyors so promoted shall continue to appear in the seniority list of Officer Surveyor.
 - (iv) The adhoc appointment may be terminated at any point of time without giving any reason thereof.
 - (v) The appointment on adhoc basis will take effect from the date of assuming the charge of the post of Superintending Surveyor.
 - (vi) The adhoc promotion will remain subject to the outcome of CWP No. 20237/2009 filed by Shri T.M. Poonja and others in the High Court of Punjab, Haryana and Chandigarh and WP No. 7683 of 2010 filed by Union of India & others.
 - (vii) As per Hon'ble CAT, Chandigarh Bench order dated 31-01-2020 in OA No. 60/1319/2019 the adhoc promotion will not affect right of the cadre from whose quota respondents are taking vacancies and their seniority will be fixed as per service rules.
- 3. In this regard an undertaking may please be obtained from the promoted officer and attach to their service book for record.
- 4. The above mentioned officers may assume the charge on promotion on ad hoc basis. Necessary certificate of assumption of charge on form 0.115 (Acc) may please be sent to this office, in triplicate, for further necessary action.
- 5. The date of accepting the promotion or the date of refusing promotion, as the case may be, may please be intimated to this office by <u>18-03-2020</u> positively. It may be made clear to the officers concerned that in case of their refusal of promotion, no fresh offer of promotion will be made to them.

- 6. In case of any vigilance case/disciplinary proceedings or pendency of punishment against the above officials is noticed at your end, the promotion orders may not be implemented.
- 7. On promotion, the individual would be required to exercise an option under FR 22(1)(a)(i) for fixation of his pay in the new scale.
