Sub:- Clarification in respect of MACP matters pursuant to upgradation of Pay Scale of Officer Surveyors.

Sir,

Please refer to your Letter No. J-7632/2158 7th CPC dated16/19 October/2020 on the subject cited above and to say that after careful examination it is clarified that on account of upgradation of pay scale of Officer Surveyor from Level-7 to Level-8 and in terms of Para 6.1 of Annexure to DoP&T OM. No. 35034/3/2015-Estt. Dt. 22-10-2019, the employees in the grade of Officer Surveyor are eligible for the benefit of placement in Level-9 and Level-10 from the date of their eligibility of MACPS or 01.01.2016, which ever is later, instead from 01.01.2020 which is the date of NFU for all other Officer Surveyors. Accordingly, the benefit in the referred cases will be given as under:
