The Director, Andhra Pradesh Geo-Spatial Data Centre, Survey of India, Hyderabad-500039 invites sealed tender for sale in one on lot "As is where is basis" of unserviceable stores (As per attached list in Annexure- "A" which are lying in our office premises and may be inspected by the bidders on any govt. working day from 11/10/2014 between 11.00 hrs to 16.00 hrs except from 13.00 hrs to 14.00 hrs to satisfy themselves about the items they are bidding for.

Last date for submission of sealed TENDER is 27.11.2014 (within 16.00 hrs). Opening of Tender date is 28.11.2014 at 11.30 hrs.

TERMS & CONDITIONS

1. Earnest Money Deposit: Earnest Money of Rs.2, 000/- (Rupees Two Thousand only) should be deposited along with the sealed tender in the shape of Demand Draft in favour of E & AO, APGDC, SURVEY OF INDIA, Hyderabad failing which tender will not be accepted.
2. Earnest Money will be returned to the unsuccessful bidders and no interest will be paid for the same.
3. Quotation should be submitted under sealed cover only.
4. Quotation should be addressed to the Director, APGDC, Survey of India, Uppal, Hyderabad-500039 and can be dropped in the office Tender box placed at Main building Entrance.
5. The envelope containing quotation must be superscribed with "QUOTATION FOR PURCHASE OF UNSERVICEABLE GOVT. STORES FOR FURNITURE DUE ON 27.11.2014.
6. The rate should be quoted in words as well as in figures No correction or overwriting in the quotation will be allowed.
7. The tender shall remain valid for 90 days from the opening date of tender.
8. If any amount is payable on account of VAT, Sale Tax or any other taxes pertaining to sale/transaction, the buyer shall be bound to pay such amount in addition to the quoted rate. All such taxes shall be deposited directly with the concerned authority and challans to be submitted to this office by the successful bidder at the time of delivery of the condemned stores.

10. The Director, APGDC, Survey of India, Hyderabad reserves the right to reject or accept any quotation without assigning any reasons thereof.
- 11. NO VARIATION IN THE BIDDING PRICE WILL BE ACCEPTED DURING THE VALIDITY PERIOD.**
12. Only the highest offer will be accepted.
13. Successful bidder will have to deposit the full amount of unserviceable stores plus the applicable taxes within 48 hours of the acceptance of his offer.
14. Items once disposed to the successful bidder shall **NOT** be taken back by SOI under any circumstances.
15. The successful bidder shall be required to lift all the items from the Survey of India, APGDC, Hyderabad premises to his site within 5 days during working hours after payment of the bid amount. In the event of failure to do so, survey of India shall have full right to forfeit the Earnest Money of the bidder. Permission to lift the material on gazetted holidays or non-working days will not be granted under any circumstances. EMD will be refunded only after bidding items are lifted from the office.
16. Tenders received after the stipulated date and time shall not be entertained in any circumstances whatsoever including postal delay, etc.
17. For final evaluation, the highest bidder shall be chosen based on the amount quoted and fulfilling tender conditions.
18. No assistance whatsoever shall be provided by Survey of India for lifting the items. The successful bidder shall have to make his own arrangements of labour and vehicle etc. for shifting the materials to his site, at his own cost. No sorting out will be allowed and no scrap materials are to be left in the office premises. If any material is not lifted then the EMD will be forfeited.
19. No separate terms & conditions are to be mentioned by the bidder.
20. The Director, APGDC, Survey of India, Hyderabad has the right to cancel the tender processing at any stage without assigning any reason thereof.
21. Bidder should quote the price in Indian rupee only.
