2.0 OTHER TERMS AND CONDITIONS

- The tender should be submitted as per enclosed Annexure 'A' in Sealed envelope duly superscribed as "Tender forCAMC of Scanner"/Tender No. 972/15-C-Computer dated 26/08/2015
- (ii) Tender duly signed by bidder must be addressed to the Director, TRIPURA MANIPUR & MIZORAM Geo-Spatial Data Centre, Survey of India, Silchar, Assam and not to any individual by name and should be dropped in the tender box situated in the premises of the O/O the Incharge, Tripura Manipur & Mizoram Geo-Spatial Data Centre, Survey of India, Malki Shillong 793 001 (Meghalaya) by 16.00 hrs on or before 24-09-2015 in person or to be sent by Registered post. Each page of the tender documents must be signed by the bidder.
- (iii) The Director, TRIPURA MANIPUR & MIZORAM Geo-Spatial Data Centre, Survey of India, Silchar, shall not be responsible for any postal delay for non received of tender by due date on time for whatsoever the reason.
- (iv) The bidder should inspect the Scanner at the office of the Incharge, Tripura Manipur & Mizoram GDC, Shillong Wing before submitting quotation and any variation/addition to the quoted amount will not be accepted. The bidder must ensured the availability of spare parts for CAMC before he quotes the rate for CAMC.
- (v) The quotation will be valid for 90 days from the date of opening.
- (vi) The bidder should furnish a certificate that all the terms and conditions of the tender document are understood by the bidder and ready to abide by the same without any variation.
- (vii) The cost of the Tender document is Rs. 100/- and is to be paid in the form of a Bank draft in favour of Establishment & Accounts Officer, Meghalaya & Arunachal Pradesh GDC, Survey of India, Shillong.
- (viii) The successful bidder has to execute an agreement at his own cost and also to submit a security deposit of 10% of the approved quotation rate through Bank guarantee.
- (ix) The Director, Tripura Manipur & Mizoram Geo-Spatial Data Centre (GDC), Survey of India, Silchar reserves the right to reject any or all tenders without assigning any reasons.
- (x) The tender document can also be down loaded by the intending bidders from Survey of India Web Site www.survey ofIndia.gov.in.
- (xi) Latest income tax clearance (Photocopy) is to be submitted along with tender.
- (xii) The bidder should submit the details of PAN in case of proprietorship. TAN in case of partnership and STC (Service Tax Code – a 15 digit number obtained Central Excise Department) being a service provider.
- (xiii) Payment for CAMC will be made in two equal installments for 6 months each on completion of such period the contract.
- (xiv) The bidder should also submit his registration certificates related to the Service tax he is paying to the Government and VAT Registration Certificate.
- (xv) Period of CAMC will be for one year from the date of signing of the agreement.
- (xvi) All breakdown complaint must be attended to within 48 hours on receipt of call.

- (xvii) Majority of faults should be rectified in the first response itself. However, maximum period allowed for defect rectification shall be 72 hours.
- (xviii) The service providing company shall have their office or branch in Shillong, Guwahati or Kolkata with qualified personnel for rendering services. If the service providing company does not have office or branch in Shillong, Guwahati or Kolkata for rendering services, their tender will be rejected outright.
- (xix) Notice for repairs/maintenance of the Scanner will be given to the Maintenance Agency by the Incharge Tripura & Mizoram GDC. Survey of India, Shillong Wing or his representatives telephonically as well as in writing in case of failure on the part of Maintenance Agency (MA) to attend the call and rectify the fault within the stipulated period of 48 hours.
- (xx) The contract will remain in force for one year from the date of signing of this agreement basing on the performance/service, it may extended/renewed on the same Terms & Conditions between the Maintenance Agency and the Director, Tripura Manipur & Mizoram GDC, Silchar for subsequent year at the discretion of this office
- (xxi) The contract covers comprehensive servicing/repairing and maintenance of Scanner as well as replacement of all defective parts by the Maintenance Agency.
- (xxii) Repairing of Plotter will be done ON-SITE. However, defective parts can be taken to Maintenance Agency lab, if necessary, with the permission of Incharge Tripura Manipur & Mizoram GDC, Survey of India, Shillong Wing. The maintenance Agency will use only original and standard spare parts.
- (xxiii) If any variation or additional taxes/duties and not statutory levies, if any, imposed by the regulatory bodied during the currency of this contract/service will be payable by the customer over & above the quoted CAMC service charges.
- (xxiv) Visit by Service Engineers of Maintenance Agency once in a month for preventive maintenance will be mandatory besides the visits in case of specific complaints.
- (xxv) If the Maintenance Agency is incapable or maintaining the Scanner, the Director, Tripura Manipur & Mizoram GDC, Survey of India, Silchar can withdraw/cancel the CAMC.
- (xxvi) The Director, Tripura Manipur & Mizoram GDC, Survey of India, Silchar may terminate the contract at any time without assigning any reasons by giving one month notice. Any dispute, if arises, the decision of the Director, Tripura Manipur & Mizoram GDC, Survey of India, Silchar, will be final.
