## 3. Eligibility Criteria:

- (i) The bidding firm should be registered with the appropriate government authorities. The copy of the Registration certificate must be enclosed along with the tender.
- (ii) The bidding firm must enclose the registration certificate of VAT/Tax obtained from the appropriate authorities. While quoting please certify that you are paying your assessed income tax and sales tax regularly.
- (iii) Copy of Service Tax registration certificate must be attached with the bid.
- (iv) The tenderer must provide the PAN/TAN number of the firm. Copies of Income tax returns filed by the firm for last 2 years should be enclosed with the tender.
- (v) The bids received without the above mentioned certificates/documents will be rejected.

## 4. Terms and Conditions:

- I. Quotation should be submitted under sealed cover only mentioning the quotation letter No. and date.
- II. All quotations should be addressed to "The Director, GIS&RS Directorate, Survey of India, Uppal, Hyderabad – 500 039". and NOT BY NAME AND NOT TO ANY OTHER ADDRESS. The complete address of your firm with Telephone & Fax number must be mentioned on the envelope.
- III. It should be clearly mentioned that whether the quoted rate is inclusive of taxes or exclusive. If the rate is exclusive of taxes, then the details and nature of the taxes and the total cost of item quoted should be specified. Tax exemption, if any, certificate to be attached along with the quotation.

- IV. The rate quoted shall be mentioned by the agency both in figure and words. There should not be any erasing or overwriting whatsoever to avoid rejection of bid. The rate quoted should remain valid for a period of 60 days from the date of opening of the bids.
- V. The Department should be provided with the details of telephone/Mobile number of Office/Residence of the engineer deputed for installation /maintenance of the Firewall.
- VI. The firm will be responsible for any loss which may be caused to the Govt. on account of damage to the equipment as a result of negligence or carelessness on the part of the firm's engineers. The loss will be recoverable from the firm.
- VII. Quote your rates making discounts (if any) on MRP and adding sales tax on selling price only (if applicable). **Quote your Net rates**. Interested tenderers can visit during office hours (Monday to Friday) to see existing peripherals.
- VIII. An Earnest money deposit (EMD) of Rs. 3,000/-(Rupees three thousand only) in shape of Demand draft drawn on any nationalized bank in favour of the "Drawing & Disbursing Officer, GIS&RS Directorate, Survey of India, Uppal, Hyderabad, payable at Hyderabad" should be furnished with the tender. The tender received without EMD will be summarily rejected. The EMD of unsuccessful tenderers will be returned within 30 days of award of job order.
  - IX. Bids received after stipulated date and time due to any reason whatsoever including postal delay shall not be considered.
  - X. The Director, GIS&RS Directorate, Survey of India, Uppal, Hyderabad reserves the right to accept or reject any/all bids without assigning any reason whatsoever.
- XI. The tender response should be signed by the tenderer in all pages. Incomplete and unsigned quotations are liable to be rejected.
- XII. Bids with overriding conditions will be summarily rejected.
- XIII. If there is no mention of taxes etc. in the bid, the bid will be considered to be inclusive of all taxes and no extra tax will be paid in any case.
- XIV. Quotations should be strictly as per specifications

- XV. Please specify the approximate time required for supply after getting supply order.
- XVI. The warranty period should be for three years.
- XVII. Consigner is responsible for safe arrival of goods at the destination. Insurance will not be paid separately by this office.
- XVIII. The successful firm would furnish security deposit of 5% of cost charges, in the form of Bank guarantee, Bank draft or FDR, valid for warranty plus two months from the date of issue.
