

- 2. Earnest Money will be returned to the unsuccessful bidders and no interest will be paid for the same.
- 3. Quotation should be submitted under sealed cover only.

- 5. The envelope containing quotation must be encrypted with "QUOTATION FOR PURCHASE OF UNSERVICEABLE GOVT. STORES DUE ON 26.07.2016".

- 6. The rate should be quoted in words as well as in figures. No correction or over writing in the quotation will be allowed while quoting the rate, tax component should invariably be shown separately.
 - 7. The tender shall remain valid for 90 days from the opening date of tender.
 - 8. If any amount is payable on account of VAT, Sale Tax or any other taxes pertaining to sale/transaction, the buyer shall be bound to pay such amount in addition to the quoted rate. All such Taxes shall be deposited directly with the concerned authority and challans to be submitted to this office by the successful bidder at the time of delivery of the condemned stores.
 - 9. The bid amount which will be deposited in the treasury of Central Government will be exclusive of taxes mentioned at Sl.No.8 above.
 - 10. Bidder, if so desires may be present at that time of opening quotations. They can also enquire about the status of their tender over telephone.

 - 12. NO VARIATION IN THE BIDDING PRICE WILL BE ACCEPTED DURING THE VALIDITY PERIOD.
 - 13. Only the highest offer will be accepted.
 - 14. Successful bidder will have to deposit the full amount of Bid value of unserviceable store plus the applicable taxes within 48 hrs. of the acceptance of this offer.
 - 15. Items once disposed to the successful bidder shall NOT be taken back by SOI under any circumstances.
 - 16. The successful bidder shall be required to lift all the items from the Survey of India, BUILDING NO. KP-11/217, 'SREEGIRI' SANTIVILA, NEMOM, TRIVANDRUM premises of his site within 5days during working hours after payment of the bid amount. In the event of failure to do so, Survey of India shall have full right to forfeit the Earnest Money of the bidder. Permission to lift the material on Gazetted holidays or non-working days will not be granted under any circumstances. EMD will be refunded only after bidding items are lifted from the office/khamal premises.

The successful bidder shall have to make his own arrangements for shifting/lifting the materials to his site, at his own risk and own cost. No sorting out will be allowed and no scrap materials are to be left in our premises. If any material is not lifted within the stipulated /permitted period then the EMD will be forfeited.
